#### Corporate actions

Where a corporate action (provided if it is not compulsory) will result in an asset that we cannot administer in the service, we may limit or not offer the ability to take up the election. If there is a compulsory corporate action that results in an asset that we cannot administer, we reserve the right to pass on additional charges and costs incurred in the process of acquiring, managing, and disposing of the asset. Assets that we cannot administer in the service include but are not limited to:

- 1. Unlisted shares
- 2. Foreign currency
- 3. Shares not on an approved exchange
- 4. Physical assets and commodities.

#### Physical settlement of underlying assets

Conversion or settlement into the physical underlying assets of an investment you hold cannot be administered on the platform. Such investments include but are not limited to:

BHP Billiton Ltd (BHP)	We have been advised that G&E KTMC Funding LLC is proposing to partially fund a shareholder class action against BHP Billiton Ltd (BHP). The proposed class action by joint applicants; Maurice Blackburn and Phi Finney McDonald (PFM), against BHP will allege that BHP failed to disclose material information to the market and engaged in misleading or deceptive conduct throughout the claim period, in relation to the Fundao tailing dam collapse at the germane mine in Minas Gerias, Brazil in 2015.

#### Dexus Wholesale Australian Property Fund NML0001AU

AMP Capital Funds Management Limited, as the responsible entity of NML0001AU, announced it has changed settlement terms from monthly to 12 month notice period. Due to this change, Dexus Capital Funds Management Limited has allowed direct investors to cancel existing on market redemption orders.

The platform will allow clients to withdraw existing redemption orders placed between 15 June 2023 and 13 May 2024. For accounts with multiple orders, we are only able to facilitate cancellations for all existing NML0001AU redemption orders.

If you choose to not participate in this cancellation offer, your units in NML0001AU will continue to be sold and payments are expected to be made within 12 months of the fund manager having received the withdrawal request. Please refer to the Fund Manager for more information about their expected payment schedule.

Note - orders after 13 May 2024 cannot be withdrawn.

Eligibility criteria may apply in respect to this corporate action which may preclude investors from participating. Online elections will be submitted as a final instruction. By accepting the offer the adviser/investor confirms they have read and understood all conditions in this event.

# Foreign Tax (including W8BENs)

#### W8BENs

Investors who are not US citizens or US residents for tax purposes and hold dual listed securities listed in the US, are required to complete a Declaration of Foreign Residency (or 'W-8BEN form'). Equivalent forms may also be needed and provided for securities listed or dually listed in other nations, such as Canada and Ireland.

Each security now requires that your clients complete a separate W-8BEN form per beneficial owner. Entities are still required to complete the W-8BEN-E form.

Search 'W8BEN' on Adviser Help Centre to download foreign tax forms and access useful information regarding foreign tax requirements.

Indicative due dates for Foreign Tax forms for this quarter are given below. Please allow 30 days for Wrap to receive, process and pass on your instructions to the relevant Third Party. Any forms received within 30 days of the record date will be processed on a best-efforts basis and may not be lodged with the share registry by the record date.
