#### **Healthcare Property Trust - Off-Market Transfer Purchase Opportunity**

Australian Unity Healthcare Property Trust - Wholesale Units (AUS0112AU) The parties to the litigation commenced by Northwest against Australian Unity Funds Management Limited ('AUFM') as responsible entity of the Australian Unity Healthcare Property Trust ('AUHPT'), Australian Unity entities and various Dexus entities, have agreed to settle the litigation. Under the Settlement Deed, AUFM has agreed to assist Northwest and its affiliate, Reco Indfund Private Limited to divest their Units by 30 June 2024.

Macquarie Investment Management Limited, as IDPS Operator of the Wrap platform and Trustee of the Macquarie Superannuation Plan will open the opportunity for existing investors to participate in the sign-up for the Off-Market Transfer Purchase. Existing investors who wish to participate will require the adviser to submit instructions via the Corporate Actions calendar. This event will be open until end of October subject to early closure.

## Foreign Tax (including W8BENs)

#### W8BENs

Investors who are not US citizens or US residents for tax purposes and hold dual listed securities listed in the US, are required to complete a Declaration of Foreign Residency (or 'W-8BEN form'). Equivalent forms may also be needed and provided for securities listed or dually listed in other nations, such as Canada and Ireland.

Each security now requires that your clients complete a separate W-8BEN form per beneficial owner. Entities are still required to complete the W-8BEN-E form.

Search 'W8BEN' on <u>Adviser Help Centre</u> to download foreign tax forms and access useful information regarding foreign tax requirements.

Indicative due dates for Foreign Tax forms for this quarter are given below. Please allow 30 days for Wrap to receive, process and pass on your instructions to the relevant Third Party. Any forms received within 30 days of the record date will be processed on a best efforts basis and may not be lodged with the share registry by the record date.
